Global Enhancements

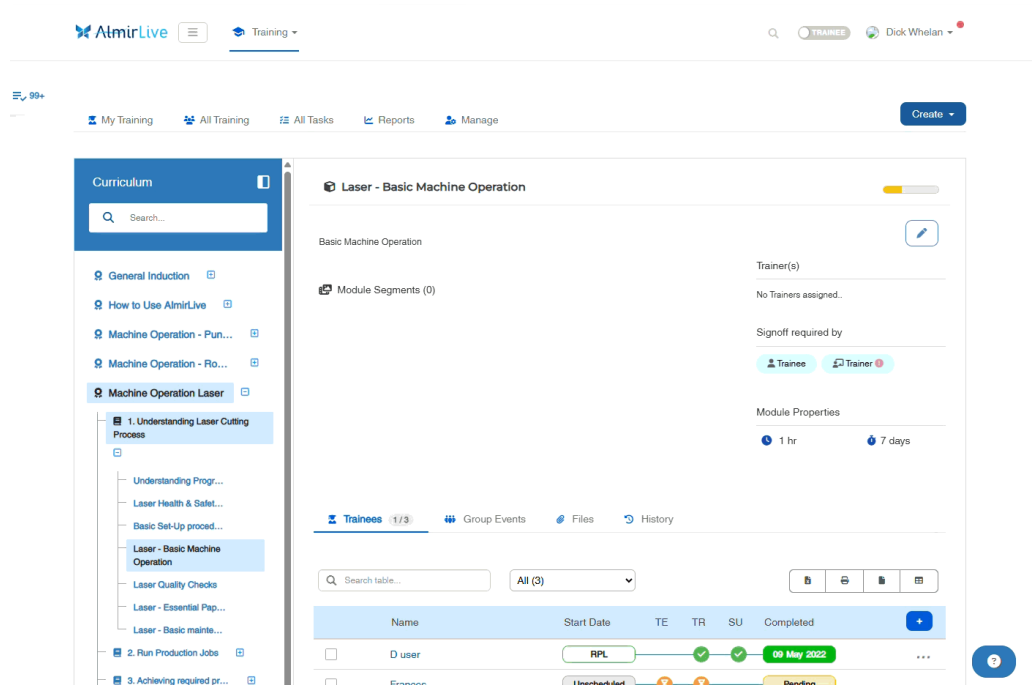
- **Improved interface consistency** – Refined dropdowns, menus, and user selectors now behave more reliably across all applications.
 - **Enhanced performance** – Faster page rendering and background loading for key dashboards.
 - **Simplified login experience** – Improved session stability and faster sign-in under high load.
 - **Signature management** – New option to delete and reset digital signatures when required for compliance.
 - **User Groups** – New option to create and manage groups / teams so they can be assigned options in bulk in future releases.

Training Application

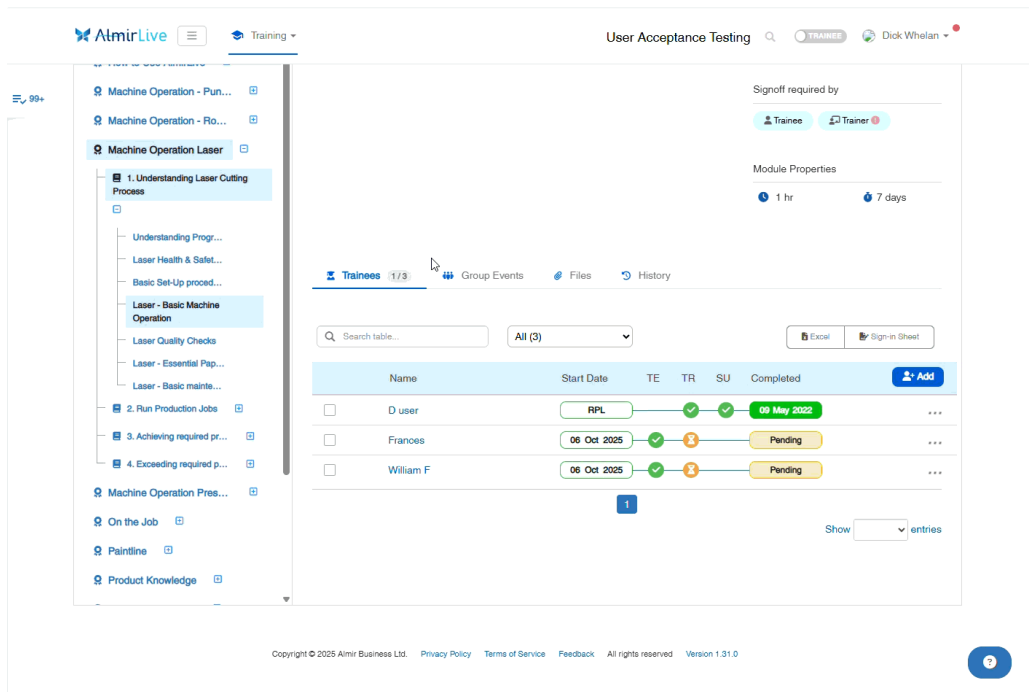
- **Streamlined navigation** – Improved navigation and layout for admin users
- **Scheduling** – When scheduling training, it is no longer necessary to add trainees to a group training event. You can schedule on an individual basis. Trainees will be notified of upcoming training.
- **Certificate bulk import** – If you have a bunch of training certificates belonging to many employees, you can easily file them in AlmirLive using our new importer.
- **Bulk sign-off and scheduling** – It's easier to mark multiple trainees as completed a module. You can schedule training for an individual or group.
- **Document-linked training** – Training sign-offs now automatically reflect the correct document revision, improving traceability. You no longer need to create a new module and link the document to it, when a document is added to AlmirLive the corresponding training module is automatically created. Simply enroll then schedule the trainees to complete the

training. Revisions are recorded at time of signoff. If you have sign offs from earlier revisions, setting the appropriate date will reflect the correct obsoleted revision.

- **Training logs added** – Each module now includes a dedicated training log view for quick sign-off and completion reviews.
- **Curriculum view improvements** – Independent modules now display correctly within the full training curriculum view.
- **Improved training notifications** – Reminder emails for document-linked training are now more reliable and easier to configure.
- **Assessment reports**– View insights from the module page for quiz question attempts

Document Control

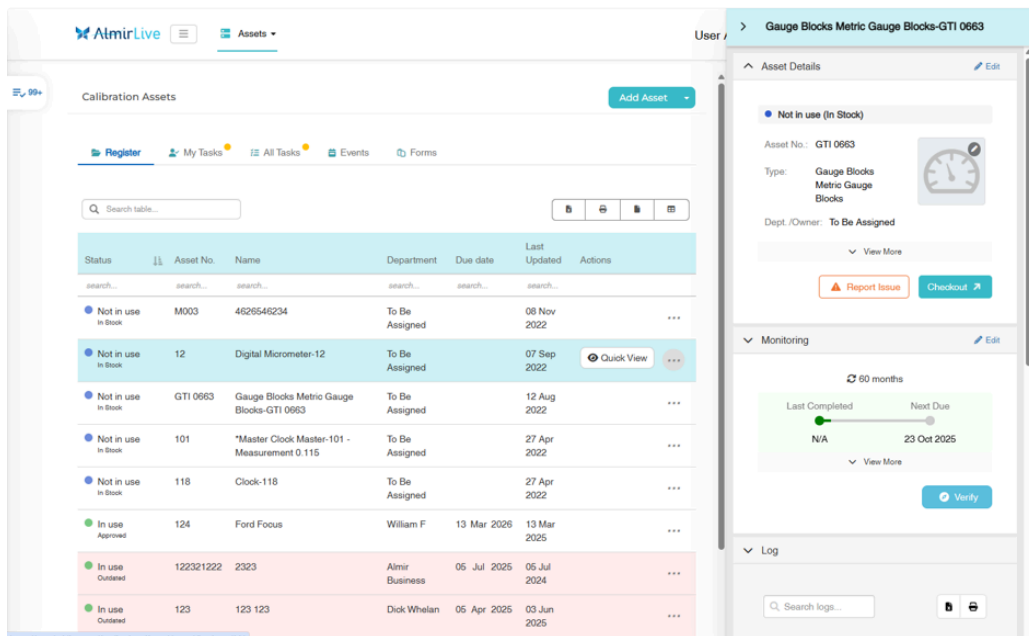
- **Improved edit experience** – Cleaner document edit screens with better validation and clearer error messaging.
 - **Activity tracking** – Editing a document now automatically records an activity log for traceability.
 - **Draft flexibility** – Document references can now be edited while the document is in draft state, giving admins greater flexibility.

Audit Management

- **Enhanced calendar filtering** – Filtering options in the Audit Calendar are now intuitive and faster to apply.

Asset Management

- **Quick view calibration asset** – View asset details in a pullout drawer without leaving the asset register.
- **Enhanced department handling** – Assets assigned to departments beginning with numeric characters now display correctly.
- **Improved asset images** – Resolved issues when adding or displaying asset photos directly from drawers.
- **Checklist view refresh** – New checklist layout provides a cleaner overview for maintenance and inspection tasks.
- **Issue assignment improvements** – Improved dropdown selection and creation of users / departments on the spot.



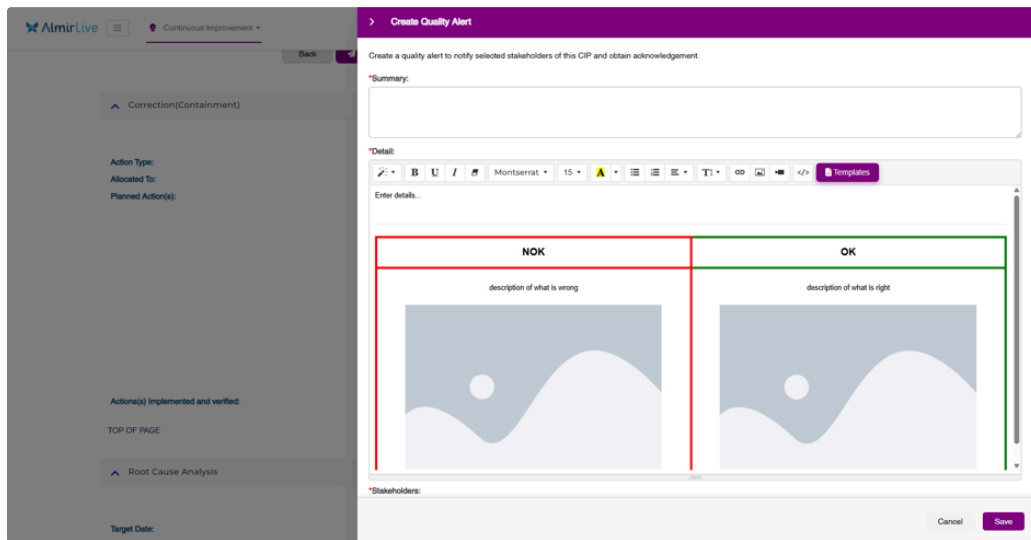
Quick View - calibration asset

CIP (Continuous Improvement)

- **Quality alert templates** – Added pre-made templates to streamline reporting of quality alerts and continuous improvement actions.
- **Full-screen editor mode** – Enhanced template editor with full-screen support for focused editing.
- **Improved accessibility** – Added keyboard tabbing support within html editor templates for faster data entry.
- **UI consistency** – Adjusted image and layout behavior to ensure CIP templates render consistently.



Reporting

- **Report availability improvements** – Reports are now accessible directly within the AlmirLive dashboard, improving discoverability.
- **New recurring training report** – Run a report on upcoming and overdue recurring training.
